### **APPOINTMENT INFORMATION**

You have an appointment with William Boucher, MD. This evaluation involves a detailed review of your history, medical records, and x-rays, and the performance of an examination. Upon your arrival you will complete a questionnaire and pain inventories that will assist us in understanding your situation. Dr. Boucher will then review the evaluation process with you and advise you of the scope and purpose of the examination and of all records that were available in the preparation and the conducting of the exam. He will then review your history, other available information, and perform a physical examination. He will perform an impartial, fair and thorough assessment of your medical condition in an effort to clarify some of the issues associated with your situation. At the conclusion of the evaluation we will prepare a report and send that report to the requesting client.

### **PREPARATION**

If you need to cancel or reschedule this appointment, please contact the office of the person who has requested this appointment no later than 10 days prior to the scheduled appointment. If you have other questions about this evaluation you should contact the person who made the referral. Please arrive on time for your scheduled appointment, it is not necessary to arrive early. If you are late, your appointment will be rescheduled and a no-show charge will be assessed. Please bring with you any x-ray films pertaining to your injury/illness. You can obtain x-ray films at the facilities where they were performed.

### **DIRECTIONS to Choice Physical Therapy:**

From Montpelier take Route 302 east to roundabout and take 2<sup>nd</sup> exit. Continue approximately 4.8 miles taking a slight right onto N. Main St/VT 14. Simply Subs Pizza is on the right. 0.3 miles past Church St. is Choice PT. If you reach Glenwood Ave you've gone too far.

From Burlington, West and Northwest Routes take Route 2 East to I-89 South towards Montpelier. Take Exit 7 merging onto VT-62 towards Route 302. Just past CVMC keep left towards Barre. At North Main St. turn right. Continue and this turns into S. Main St. 0.3 miles past Church St. is Choice PT. If you reach Glenwood Ave you've gone too far.

From St. Johnsbury and Newport areas take Route 2 West to Route 14 South continuing 5.1 miles turning left onto North Main St./Rte. 302/VT 14. (Just past Mister Z's Italian Rest. on the corner). Continue approx. ½ miles to slight right on N. Main St. Choice PT is 0.3 miles past Church St. If you reach Glenwood Ave you've gone too far.

From points south, take I-89 North to Exit 6 and merge onto VT-63 toward VT-14/South Barre/Barre. Go 4 miles turning left onto South Barre Rd/VT-14 continuing 1.4 miles to VT-14. 84 S. Main St. is on the right with your destination being just past Glenwood Ave. If you reach Church St. you've gone about 0.3 miles too far.
